Minutes of the Meeting

The minutes of the October 26, 2016 meeting were approved as distributed.

Motion to Revise the Membership of EMC

The motion to revise the membership of the Enrollment Management Committee was approved. The Enrollment Management Committee sets the Enrollment targets for the university.

Approved by EMC, 11/11/16

Motion: *Additions/deletions* Effective immediately.

The Enrollment Management Committee (EMC) will be composed of the Provost, the *Vice President for Enrollment Management and Student Success* ~~Associate Provost for Academic Programs~~, the Associate Provost for Institutional Effectiveness, the *Associate Vice President of Admissions* ~~Director of Admissions~~, the Director of Financial Aid, the *University Registrar* ~~Registrar/Assistant Vice President for Enrollment Services~~, the *Associate Vice President of Student Success* ~~Academic Director for Student Retention~~, *the Vice Provost and Dean of Perimeter College*, *the Associate Provost for Graduate Programs*, ~~the Director of University Honors Program~~, two representatives of the Deans (selected by the Council of Deans), the chair of the Senate Committee on Admissions and Standards, a faculty member from the Senate Committee on Diversity, a faculty member from the Senate Committee on Planning and Development, a faculty member from the Senate Budget Committee, a faculty member from the Senate Committee on Student Life and Development, and three faculty members from the Senate Committee on Admissions and Standards.

Rationale: The membership of the EMC needs to be adjusted to reflect the consolidation with Perimeter College and the addition of graduate issues to the purview of Admissions & Standards.

Undergraduate Cross-Registration Policy

The motion to create an Undergraduate Cross Level Registration Policy was approved.

Proposed addition to Bachelor-Level Undergraduate Catalog, within Section 1330:

Atlanta Campus (baccalaureate degree-seeking) students must receive advance written authorization to be allowed to register for Perimeter College courses. Students may take up to four Perimeter College courses, during summer semester only, provided they:

- satisfy all prerequisites for the courses
- have completed 12 credit hours at the Atlanta Campus
- have a minimum institutional GPA of 2.0

Under extraordinary circumstances, students may seek advance written authorization to take Perimeter College courses during the fall or spring semesters. Any such approved courses will count towards the four-course limit.

Please check with the University Advisement Center or the Office of Academic Assistance in the college for additional details.

Proposed addition to Associate-Level Undergraduate Catalog, within Section 1330:

Perimeter College (associate degree-seeking) students must receive advance written authorization to be allowed to register for Atlanta Campus courses. Students may take up to four Atlanta Campus courses, provided they:

- satisfy all prerequisites for the courses
- have completed 30 credit hours (12 of which must have been completed at Perimeter College)
- have a minimum institutional GPA of 2.5

Please check with the University Advisement Center for additional details.

Rationale: Students at Georgia State and Georgia Perimeter College used to be able to attend the other institution as transient students. With consolidation this is no longer possible. The Consolidation Implementation Committee recommended that policies be adopted to ensure that this ability remained where it is appropriate to do so. There are times that 4 year students may need to take a class at Perimeter College. This is something that students have often done during the summer and it can support progression. There are occasions that Perimeter College students may want to take courses at the Atlanta campus to support progression as well; for example, if they are nearing completion of their 2-year degree and need additional coursework to remain enrolled as a full time student.

Math Placement Scoring Chart

Allison Calhoun-Brown presented the Math Placement Scoring Chart as an information item. To have consistency across all campuses and required by the Board of Regents, the Math Departments at both the PC Campus and Atlanta Campus agreed on a standard score of 84 for all students who want to enroll in a math course higher than Math 1101.
