## Bhakti Yoga

# **Information Items / Discussion**

- A. Dr. Darryl Holloman spoke on the following:
  - o Provided an overview of the Office of the Dean of Students
  - o Announced that Bernard McCrary is the new director of Black Student Achievement and Jeffrey Coleman is the new director of the Multicultural Center
  - His mantra is How do we build a culture of care? He wants to create a balance between a welcoming campus and student advocacy. He wants an environment that is an inclusive, equitable environment and that advocates for students.
  - o Things to focus on
    - 1. How we engage students now?
    - 2. How are we supporting students?
    - 3. How do we expand on multicultural on campus?
    - 4. Challenges? We do not talk about the diversity of thought
    - 5. Student Conduct Safety of campus, how to adjudicate issues.
  - o Need to train faculty and students on sexual misconduct policy.
  - The name of the staff members that do student assistants is changing to student advocacy and outreach; as it better describes what they do.
  - Dean on Students is not just for when students are in trouble. He has an open door policy for students and parents.
  - 112 is an off-campus student housing facility that is not under jurisdiction of Georgia State University.
  - Multicultural Center LGBT community, Hispanic Latino/a, white males, Asian students, etc
  - Changes to MLK Convocation Name changed to MLK Commemoration. The program will focus more on the speaker and will only have two awards.
- B. First Amendment- There is difficulty regulating speech on campus, as any actions by campus is considered State action. We can have time, place, and manner restrictions. There are designated areas on campus for free speech. Many concerns were discussed regarding the most recent activity involving free speech in Library Plaza. Concerns were raised regarding the way students were being treated and the noise level that made working difficult. A suggestion was made regarding moving the free speech area to Hurt Park. Further conversations regarding this topic are needed. Key staff members are going to be meeting with the police department to discuss some of the concerns as well. Some helpful ways to help students cope included providing educational materials on using meaningful speech, on what goes on campus and how to cope, and what the campus can and can't do.
